At the RVNA Center for Exceptional Care, our Rehabilitation team provided outpatient physical, occupational and speech therapy, massage and Reiki, and ongoing aftercare programs.

The RVNA Rehabilitation Center offers comprehensive therapies for conditions such as:

- Joint replacement surgeries (knee, hip, shoulder)
- Stroke/neurological recovery
- Orthopedic injury and back pain
- General muscular/skeletal injury
- Parkinson's, ALS and Multiple Sclerosis
- Falls/balance training

Our interdisciplinary hospice team serves patients and loved ones, providing physical, emotional and psychosocial support for those with a life-limiting illness. Services are offered in a patient's home, bringing expertise and care amidst the people and memories one treasures the most.

- Home Health Aides
- Medical equipment, supplies and medications
- Volunteers for companionship, Reiki, massage and more
- Bereavement Counseling and Support Groups
- Rehabilitation Therapies and Nutrition Counseling





Caregivers support those with agerelated needs, short-term and respite needs, dementia, degenerative diseases, and terminal conditions.

Some of the services RVNA caregivers provide include:




NET SERVICE REVENUE DEVELOPMENT/OTHER REVENUE OPERATING COSTS
